## Court-Related Services

*Fountain Hill Center's Court Related Services provide comprehensive evaluative and supportive services for both clients and courts with a range of therapeutic and consultative options. We support courts in the search for sustainable solutions to litigation and recidivism obstacles. We support clients in the family and criminal courts to identify needs, create communications, and develop long term healthy solutions.*

### MEN'S THERAPY & ASSESSMENTS



The Men's Resource Center provides assessments and specialized individual and group counseling for men relating to divorce recovery, fathering, co-parenting, anger, domestic abuse, sexual acting out, and substance abuse. ### WOMEN'S THERAPY & ASSESSMENTS

Specialized individual and group services are available for women who are convicted of criminal charges; whose spouse/partner is sexually addicted; who are living in or recently left an abusive relationship; or struggling with anger management issues. Individual intake sessions determine the course of counseling most appropriate for each client.

### SUBSTANCE ABUSE ASSESSMENTS & TREATMENT

Pre-sentence assessments and drivers' license reinstatement evaluations are available for drug and alcohol related offenses.

### PRE-MARITAL COUNSELING

Counseling to fulfill marriage licensing requirements as well as counseling to address marriage communication and wellness issues.

### IMMIGRATION HARDSHIP WAIVERS

After short term counseling and assessment, we provide comprehensive letters that illustrate the hardships a US citizen would face if their spouse or relative going through the immigration process were forced to return to their country of origin for the mandatory 10 year waiting period. This letter may be used to apply for a provisionary waiver that would allow the US citizen's loved one to remain with them in the United States during the immigration process.

### PARENT-CHILD REUNIFICATION

This is used to facilitate the re-unification of the relationship between parent and child/ren after separation. Client specific treatment plans will consist of individual, joint, and family sessions. Parents, children and families will work with a therapist to address the catalyst of the issue and to promote restoration and accountability. Services may include various experiential therapies, such as equine therapy.

### PARENT COORDINATION

This service is a longer-term process to help families in transition make decisions regarding their children rather than assigning that responsibility to the court. They learn better ways to communicate and come to agreements. *The process can be six months or longer and may involve collateral contacts.*

### CUSTODY/PARENTING TIME EVALUATIONS

Individual, Family and Collateral Assessment interviews are conducted along with the use of Psychological Testing to determine the best interest of children related to custody and parenting time.

### PARENTING FITNESS EVALUATIONS

A focused evaluation is conducted related to custody and parenting time. A focused evaluation can also be conducted for specific allegations or concerns such as domestic abuse, parental alienating behaviors, sexual acting out (i.e. sex addiction), substance abuse or poor parenting.

### THERAPEUTIC SUPERVISED PARENTING TIME

This service is more than a typical supervised parenting session. The session includes feedback and coaching to the parent during and after the supervised session in order to sharpen parenting skills. The space provides a safe and therapeutic environment where parenting time can occur. The focus is on fostering confidence for both the child and parent in order to develop necessary parenting skills and improve family system health.

### EXPERT TESTIMONY

Expertise include: custody and parenting, domestic abuse, sexual abuse, and other clinical issues. Fees include preparation, phone consultation, time allotted for court (door to door), and court time cancelled with less than three days' notice.
